The Leverage Shares 2x Long TER Daily ETF (the "Fund") seeks daily leveraged investment results and is very different from most other exchange-traded funds.

As a result, the Fund may be riskier than alternatives that do not use leverage because the Fund's objective is to magnify (200%) the daily performance of the publicly traded common stock of Teradyne, Inc. (NASDAQ: TER) (TER or Underlying Security).

For periods longer than a single day, the Fund will lose money if TER's performance is flat, and it is possible that the Fund will lose money even if TER's performance increases over a period longer than a single day. An investor could lose the full principal value of his/her investment within a single day if the price of TER falls by more than 50% in one trading day.

Leverage Risk: The Fund obtains investment exposure in excess of its net assets by utilizing leverage and may lose more money in market conditions that are adverse to its investment objective than a fund that does not utilize leverage.
